This application is essentially a minor amendment to the consented applications 24/02647/FUL and 24/02643/LBC. The consented applications altered the existing single storey stone outshoot into a high quality contemporary garden room, only modestly extended from the original building line by 1.575m. This application proposed to further extend this extension by another modest depth of additional 1m, resulting in a total extension depth of only 2.575m from the existing outshoot building line.
