The existing driveway is estimated to be around 100 years old and is narrow by modern standards and allows less than 10 cm clearance on each side of a modest modern car. This creates undue risk of damage to each of car and driveway railing in addition to being a distraction causing reduced safety for adjacent pedestrians, cyclists and vehicular traffic on Sciennes Road. The proposal is to widen the gate access by modest amount and conform with 3m permitted driveway width in the Grange.

The proposed widening is modest in terms of scale. Only the access point (gate and wall) is widened. There is no proposal to widen driveway beyond the gate. The existing driveway is a soakaway spaced granite cobble over earth type. Existing driveways on this street are very few but the three known within 100m are actually wider than the 3m access suggested in the Grange Conservation Area guidance document. The driveway will be more usable - effectively releasing one unit of onstreet parking
