As part of Hutchison 3G UK Limited's ongoing commitment of keeping Local Planning Authorities informed of electronic communications development in their area we can now provide details of our intention to install telecommunications apparatus at the above location.

In accordance with Regulation 5 of the Electronic Communications Code (Conditions and Restrictions) Regulations 2003 (as amended) this letter provides formal notification in writing of 28 days notice in advance, of our intention to install electronic communications equipment. No fee is required for the notification.

Hutchison 3G UK Limited intends to utilise its permitted development rights as identified in Part 20, Class 67 of the Town and Country Planning (General Permitted Development) (Scotland) Order 1992 (as amended). The proposals contained herein constitute permitted development under Class A (a).

For the avoidance of doubt this letter does not constitute:

- An application for a determination as to whether the prior approval of the authority will be required to siting and appearance; or
- An application for planning permission

There is no fee for the Notification.

REMOVAL AND REPLACEMENT OF 3NO. ANTENNAS, INTERNAL CABINET WORKS, ANGLARY WORKS


